4b (Code: ) (Expenses \$ 9688. including grants of \$ 9688. ) (Revenue \$ ) Water & Sanitation: The non-governmental organization called BLESS, an Indian charity with government recognition, asked World Children International to provide funds to build a toilet for the Railway Colony School. This Catholic church-administered school is located in Viluppuram, a small community in the Indian state of Tamil Nadu. The school has 1,730 students and 56 teachers but has no toilet facility. All the students must use a railroad drainage canal about 150 yards from the school as their toilet. This is not such a big problem for the boys, but for the 764 girls using an open area as their toilet is both humiliating and dangerous.

WCI raised funds to construct an ecologically designed toilet, using
